PESC-5: 5th Pan-European stakeholder consultation for the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES)

Date and place: 6-7 June 2018, Bern, Switzerland

Duration: 2 full days (including uptake event for the European & Central Asian (ECA) Regional Assessment by IPBES on first morning)

Objectives of PESC-5

- 1. Discuss uptake of IPBES ECA Regional Assessment policy output
- 2. Promote stakeholders' engagement in IPBES work
- 3. Contribute to the preparation of IPBES products through in-kind support
- (2nd review of the Global Assessment, options for 2nd Work programme of IPBES)
- 4. Strengthen collaboration on biodiversity research at the pan-European level, including Central Asia

Expected outputs

- Shared experience and strategies on how to increase the uptake of ECA Assessment findings in each country, and in different sectors.
- Comments on the 2nd draft of the Global Assessment, to be submitted to IPBES as a stakeholders' perspective during the open review phase.
- Roadmap for setting up a national coordination for IPBES (key stakeholders to be involved, key activities, communication plan...) in willing countries

Target audience

Knowledge holders from Pan-Europe (Western and Eastern Europe as well as Central Asia) affiliated to governmental and administrative bodies of IPBES member states or nonmember states, European Commission, IPBES subsidiary bodies, scientific institutions, research programmers and funders, non-governmental organisations, other civil-society organisations and businesses, dealing with issues related to biodiversity and ecosystem services. Enhanced efforts will be dedicated to the participation of social science and Indigenous and Local Knowledge experts, of biodiversity practitioners, policy experts and IPBES National Focal Points of European and Central Asian countries.
